It is a criminal offence if, without reasonable excuse, you fail to do this, or the notification you give contains false or misleading information or you are reckless as to whether the information is true and not misleading.

Whilst not a statutory requirement, the Code of Conduct for Members requires you to notify the Clerk within 28 days of any new disclosable pecuniary interest, or any change to a disclosable pecuniary interest already notified/registered.
