**Notification by Member of a Local Authority of Disclosable

Part 1

Disclosable Pecuniary Interests

(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the **relevant person** has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

(A **relevant person** is you, your spouse or civil partner, a person with whom you are living as husband and wife, or a person with whom you are living as if you were civil partners)

Please note, that the law requires you to notify the Council's Monitoring Officer, within 28 days of election or appointment, of **any** disclosable pecuniary interest which you have at the date of this notification. You are required to update this notification if you are re-elected or re-appointed. It is a criminal offence if, without reasonable excuse, you fail to do this, or the notification you give contains false or misleading information or you are reckless as to whether the information is true and not misleading.

Whilst not a statutory requirement, the Code of Conduct for Members requires you to notify the Monitoring Officer within 28 days of any new disclosable pecuniary interest, or any change to a disclosable pecuniary interest already notified/registered.
