

Licensing Act 2003 Determination of interim measures in advance of a full Review of Premises Licence application under the Expedited (Summary) Review process

PURPOSE

- 1. To advise members of the requirement to determine the request for interim measures to be imposed under the Expedited (Summary) Review process under Section 53 A-C of the Licensing Act 2003. There then will be a full Review Hearing for the Premises and this will be subject of a hearing within 28 days, and that will have all the usual relevant papers and reports circulated prior to that full hearing.
- 2. The premises is The Angel Inn, 80 Accrington Road, Burnley, BB11 4AU.

RECOMMENDATION

3. Members are recommended to make a determination at the conclusion of the hearing as required by legislation.

Having considered all relevant facts, the interim steps that the licensing authority must consider taking are:

- the modification of the conditions of the premises licence;
- the exclusion of the sale of alcohol by retail from the scope of the licence;
- the removal of the designated premises supervisor from the licence; and
- the suspension of the licence.

REASONS FOR RECOMMENDATION

4. Members of the Licensing Committee are responsible for determining such applications.

SUMMARY OF KEY POINTS

- 5. The Licensing Objectives are:
 - Prevention of Crime and Disorder
 - Public Safety
 - Prevention of Public Nuisance
 - Protection of Children from Harm

This premises holds a Premises Licence issued by Burnley Borough Council, PLA 0002.

The Premises Licence Holder and the DPS is Jackie Davies, who resides at the same address as the Pub.

Jackie Davies also holds a Personal Licence which was issued by Burnley Council on the 11th November 2015.

A copy of the Premises Licence is attached at Appendix A.

6 At 3pm on the Wednesday 18th November 2020, the Licensing Authority received an application from PC Michael Jones, Lancashire Constabulary Licensing Unit, Burnley Police Station for an expedited (summary) review of the Angel Inn, Burnley.

This is attached at Appendix B

This was accompanied by a signed Certificate from a Senior Police Officer authorising the application, under section 53A(1)(b) of the Licensing Act 2003.

This is attached at Appendix C

The grounds for the application are outlined in the papers (Appendix B & C)

The interim steps that the licensing authority must consider taking are:

- □ the modification of the conditions of the premises licence;
- \Box the exclusion of the sale of alcohol by retail from the scope of the licence;
- □ the removal of the designated premises supervisor from the licence; and
- \Box the suspension of the licence.

The Police are requesting that the interim steps are that the Premises Licence is suspended pending the full licensing hearing.

- 8. The following paragraphs from Burnley Borough Council's Statement of Licensing Policy are relevant to this application:
 - 1.10 We will endeavor to carry out our licensing functions in a way that:
 - o ensures public safety
 - supports well managed premises where licence holders seek to actively promote the licensing objectives and display sensitivity to the potential impact of licensable activities on local residents and other businesses
 - o protects residents' quality of life.

3.10 The public safety objective is concerned with the physical state of people using the premises. Public safety includes safety of performers appearing at any premises and any

7.7 Where there is evidence that one or more licensing objectives would be undermined, a responsible authority, authorised person or interested party (Since the introduction of the Policing and Crime Act 2009 the definition of "interested Parties" has been extended to include – "a member of the relevant Licensing Authority") has the ability to object to the issue or variation of a licence or request a review of an existing licence.

13.4 The holder of a premises licence which includes the sale and supply of alcohol must nominate a Designated Premises Supervisor (DPS). That person will normally have been given day to day responsibility for running the premises. The DPS will also be in possession of a personal licence. The Act does not require the presence of the DPS at all material times.

13.5 The DPS will be readily identifiable on the premises as a person in a position of authority. No sale or supply of alcohol may be made at a time when no DPS has been specified on the licence or at a time when the DPS does not hold a Personal Licence.

14.4 The Violent Crime Reduction Act 2006 has amended parts of the Licensing Act 2003 and now expands police and council powers to deal with problem premises in a more expedient manner.

14.5 A new power to carry out summary reviews in serious cases of crime and disorder is brought in at section 53A of the Licensing Act 2003. Where a review application is accompanied by a certificate issued by a senior police officer, the Licensing Authority is required within 48 hours to consider whether it is necessary to take any interim steps pending the completion of the review process. This may include the immediate suspension of the premises licence.

Human Rights Act Considerations

Members are reminded of the consideration they should give to the Human Rights Act 1998 in particular those rights afforded by Article 6 (right to a fair hearing), Article 1 of the First Protocol (protection of property) and Article 8 (right to respect for private and family life).

DETAILS OF CONSULTATION

9. The Premises Licence Holder and DPS Jackie Davies was made aware of the application on the same day as it was received and accepted by the Licensing Authority and she was advised to get urgent legal advice, and also was given the opportunity to make written representations for this hearing.

ANNEX 1 - MANDATORY CONDITIONS

Mandatory Conditions

All Premises Licence authorising supply of alcohol

The licence is granted subject to the Mandatory conditions for sale of alcohol as set out in the Licensing Act 2003 as amended by the Licensing Act 2003 (Mandatory Licensing Conditions) Order 2010 and Order 2014.

- 1. No supply of alcohol may be made under the Premises Licence -
 - (a) At a time when there is no Designated Premises Supervisor in respect of the Premises Licence; or
 - (b) At a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended.
- 2. Every supply of alcohol under the Premises Licence must be made, or authorised by a person who holds a Personal Licence.
- 3. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
 - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises.
 - a) games or other activities which require or encourage, or are designed to require or encourage, individuals to -

- 6. The responsible person shall ensure that -
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures -
 - (i) beer or cider: 1/2 pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
 - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

Minimum Drinks Pricing

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1 -
 - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979
 - (b) "permitted price" is the price found by applying the formula -

 $\mathsf{P} = \mathsf{D} + (\mathsf{D}\mathsf{x}\mathsf{V})$

Where -

(i)P is the permitted price

- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence -
 - (i) The holder of the premises licence
 - (ii) The designated premises supervisor (if any) in respect of such a licence, or
 - (iii) The personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from the paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

If the Premises Licence allows Exhibition of Films

condition requiring the admission of children to the exhibition of any film to be restricted in accordance with this section.

2.Where the film classification body is specified in the licence, unless subsection (3)(b) applies, admission of children must be restricted in accordance with any recommendation by that body.

3.Where

- (a) The film classification body is not specified in the licence, or
- (b) The relevant licensing authority has notified the holder of the licence that this subsection applies to the film in question,

admission of children must be restricted in accordance with any recommendation made by that licensing authority.

4.In this section "children" means any person aged under 18; and

"film classification body" means the person or persons designated as the authority under Section 4 of the Video Recordings Act 1984(c39) (authority to determine suitability of video works for classification).

If the Premises Licence has conditions in respect of Door Supervision

except theatres, cinemas, bingo halls and casinos

1. Where a premises licence includes a condition that at specified times one or more individuals must be at the premises to carry out a security activity, each such individual must:

(a) be authorised to carry out that activity by a licence granted under the Private Security Industry Act 2001; or

(b) be entitled to carry out that activity by virtue of section 4 of the Act.

2.But nothing in subsection (1) requires such a condition to be imposed:

(a) in respect of premises within paragraph 8(3)(a) of Schedule 2 to the Private Security Industry Act 2001 (c12) (premises with premises licences authorising plays or films); or

(b) in respect of premises in relation to:

(i) any occasion mentioned in paragraph 8(3)(b) or (c) of that Schedule (premises being used exclusively by club with club premises certificate, under a temporary event notice authorising plays or films or under a gaming licence), or

(ii) any occasion within paragraph 8(3)(d) of that Schedule (occasions prescribed by regulations under that Act.

3.For the purposes of this section:

(a) "security activity" means an activity to which paragraph 2(1)(a) of that Schedule applies, and, which is licensable conduct for the purposes of that Act, (see Section 3(2) of that Act) and

(b) paragraph 8(5) of that Schedule (interpretation of references to an occasion) applies as it applies in relation to paragraph 8 of that Schedule.

ANNEX 2 - Conditions consistent with the Operating Schedule

CCTV shall be installed to the satisfaction of the police and that all recorded images shall be retained for a period of 28 days and must be made available to the police or licensing authority on request.

Whenever the DPS is not at the premises another person shall be nominated by them to be the responsible person to manage the premises.

Notices shall be displayed on the premises requesting customers to leave quietly.

The Challenge 21 scheme shall be implemented at the premises.

Only the UK photo driving licence, passport or government approved PASS cards shall be accepted as proof of age.

During the current Coronavirus pandemic, Lancashire Police has received numerous complaints regarding the premises not abiding by the various restrictions that have been in place at different times.

Since the introduction of restrictions in March 2020 the premises has had the highest number of reported incidents in the BB11 postcode area.

On the 17th of October Lancashire entered into Tier 3 restrictions, which amongst other restrictions restricted licence premises to only being allowed to serve alcohol as part of a substantial meal.

At 17;18 on the 17th of October 2020,the day which Lancashire entered Tier 3 restrictions, PC Dave Greenwood attended the premises following a report that it was open and not serving food with alcohol.

PC Greenwood was concerned that the Track and Trace book contained very limited details and that tables were too close together,little social distancing displayed and customers clearly not from the same household sitting together. Although the officer noted that there was a pie warmer within the premises containing pies,he could see little evidence of customers eating. The officer noted that he could see males within the games room sitting together,walking in and out without any social distancing. The officer also noted some males sitting individually opposite the bar with 4 or 5 pints of beer each lined up with little or no evidence of food consumption. The officer spoke with Jackie and Mark Davies.

At 16:55 hours on Saturday the 24th of October , just one week after the previous visit, another complaint was made regarding the suspected breaching of the restrictions.

PC Carla Martin states that she arrived at the premises but found the door to be locked.She could see that the lights were on inside and people sitting inside. The officer was allowed entry and although social distancing appeared to have improved, the officer was concerned over a lack of food being consumed. The officer noted between 20 to 30 people inside but recalls only one table eating which appeared to be a tray of pie and peas. Further investigations have identified that on that date up to 20 customers have been allowed to stay at the premises for up to 2 1/2 hours, being served alcohol but no food consumed.

On the 4th of November 2020 the latest lockdown regululations came into force requiring all hospitality premises to remain closed.

At 21:15 hours on Wednesday the 11th of November, PC Lee Ingham was tasked with conducting checks at premises within the Burnley area to ensure compliance with the lockdown regulations.

The officer will state that he attended the premises and noted that all but one of the curtains were closed but could see light from one of the windows. As he got out of his vehicle he could hear music and managed to look above an advertisement sticker in the window and saw several people sitting drinking near to the bar. The officer observed the occupants for about five seconds before being spotted and witnessed the people run towards the rear of the pub. With the assistance of other officers, the exits were secured and PC Ingham knocked on the front door which was answered by a female after a delay of

about two minutes, the fendate explained that she was including of the plenhises and was alone. The officer explained what he had witnessed but the female continued to maintain that she was alone and that nobody had been drinking. The officer noted that the music had stopped and glasses had been removed. Officers then conducted a search of the premises and found three people hiding in an upstairs room. All persons present were issued with Penalty Notices for the offences.

In addition to these incidents, numerous visits have been made to the venue since the summer and poor practices have been observed. This includes CCTV not working, poor track & trace recording - including offensive jokey names, Mark Davies being highly intoxicated, loud music and singing and poor social distancing.

It is the view of Lancashire Constabulary that the Designated Premises Supervisor is guilty of the Common Law offence of Public Nuisance, which, in a worldwide pandemic would constitute a serious Crime, which undermines the Prevention of Crime and Disorder, Public Safety and Prevention of Public Nuisance licensing objectives.

A person is guilty of the offence if he/she

(a) does an act not warranted by law, or

(b) omits to discharge a legal duty,

if the effect of the act or omission is to endanger the life, health, property, morals, or comfort of the public, or to obstruct the public in the exercise or enjoyment of rights common to everyone.

It would be the recommendation of Lancashire Constabulary that serious consideration is given to suspending the premises licence, pending a full review hearing to avoid any further undermining of the licensing objectives, along with mitigating public health risks, if pubs are allowed to reopen in December.

Further evidence and information in relation to this will be provided to the Premise Licence Holders prior to the full review hearing.

The pub has come to police attention on a number of occasions since lockdown measures were introduced in March 2020. Police and Council officials have tried to work with the pub on a number of occasions for a period of time and advice has not been heeded - with fines now being issued at the venue for breaching regulations.

The pub has had the highest number of reported incidents in the BB11 postcode area since March and the owners are clearly flouting the guidance and
